Lightwood is proposing to create a new village at Murrell Green located between Hook, Winchfield and Hartley Wintney. The location and extent of the site is shown overleaf.

The proposed new village is envisaged to comprise up to 2,200 homes, local centres with commercial and community uses, a new all-through school (pre-school, primary and secondary), employment land, areas of public open space, sports and play provision, areas for wildlife enhancement along with associated infrastructure with vehicular accesses provided from the A30 London Road and B3016 Odiham Road.

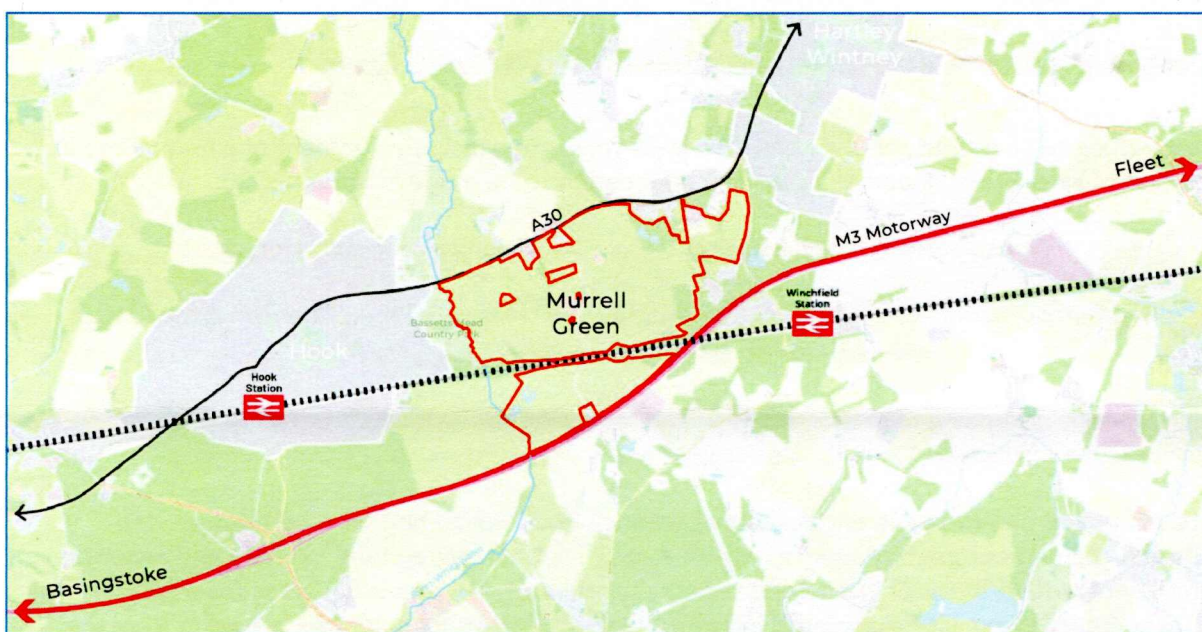
